## 1<sup>st</sup> DAY / MARCH 20

8.30 a.m : opening of the meeting by Maarten BRAND, President of EFBA. Thanks to Kevin Mc Ardle and Tim O'Mahoni to welcome the EFBA delegation in Dublin. Each member introduces him/herself.

#### **1st POINT: ADOPTION OF THE DRAFT AGENDA**

The agenda is adopted. The standard contract and legislation in Brussels issues are added to the agenda

### 2nd POINT : ACTIVITY REPORTS FROM EACH ASSOCIATION

#### → Kevin Mc ARDLE and Tim O'MAHONY: IFMA and the IRISH market (ref PowerPoint).

Kevin Mc Ardle makes a presentation of the Irish association (IFMA) composed of 4 members :

- Goulding chemical
- Grassland fertilizers
- Goulding fertilizers (Kilkenny)
- Target fertilizers

Represents 59% of the total distribution of fertilisers.

No primary manufacturer, all is imported.

Different items on the presentation : key statistics of Republic of Ireland, Irish land use (80% pasture), the market (continuous decline – 260T in 2011/2012), delivery system (20% of bulk, 55% of 500kg big bags (palletised by 4), 25% of 50kg bags (2 tonne pallets)), 200 customers, seasonality of fertilisers in Ireland just like in the rest of Europe, total market 1.210.000 Million tonnes.

Current issues :

- New EU regulations: 4 working groups heavily impact on manufacturers, need to address them in the name of EFBA.
- The system of declaration (label) is very difficult to apply for small lots, use pre printed bags. Pier Luigi Graziano adds that the label consists of declaring the main components and demonstrating that use the right amount of the different components and eventually to show that the difference is due to segregation. This is only a suggestion from the working group.
- ↓ High level of tolerances to be introduced makes things difficult.
- ↓ Traceability system is difficult for small producers.
- To give the origin of each components is compulsory. Remarks are made on the exact meaning of "origin" (misunderstanding), it does not mean country of origin but the origin of the blend itself.
- New possible tax on plastic packaging.
- 4 13,5% of unemployment in Republic of Ireland for a population of 4.5 millions inhabitants.
- Farm income increased of 48% in 2010: competitiveness improved because of government actions.
- P and K replaced by P.
- Common agricultural Policy (CAP reform): fight for flexibility since only the people who farm get the payment, hope to maintain a 1.6 billion budget, productive farms could lose from 3 to 5% of their current pay.
- In 1984, Ireland produced 7 billion litres of milk like New Zealand, today the same quantity and NZ 19 billion litres.
- For 2020, a plan is put in place to increase primary production (Ireland produce 1% of total world production; 4<sup>th</sup> largest exporter of beef, 90% of the production is exported mostly in UK, high quality meat).
- → Maarten J. Brand : NVB and the Dutch market (Overview of the European blending market in 2008-2012).

Comments :

- Should find the consumption of nutrients for each country, interesting data (ref. Fertiliser Europe website). Better figures needed to have a real photograph of the blending.
- ↓ In 2012, 125.000 T of blends, blending is slowly increasing.
- Maarten Brand proposes to send by email to each participant the information from the LEI (Wageningen University) on the price paid by the farm for the products that are delivered.
- The map of Holland shows that there are rivers/canal all over the country that allow all transport by boat at low cost.
- Members of the N.V.B. (18) represent 90% of the blends in Holland.
- Last year, information on the quality system was given (ref Minutes Portugal 2012). Since then, two new members are implementing the system in the North and the Southwest that means 4 members from all over the country are applying the system. Expect pressure from the government to use the quality system BlendPlus!

# → Pier Luigi GRAZIANO –AIF and the Italian market (ref. Power point blended fertilisers in Italy)

<u>Comments</u>:

- 4 260 fertiliser manufacturers, 1200 registered.
- **4** 8 blended fertiliser companies produce 50% of the total blended fertilisers.
- ↓ The ISTAT figures given are very reliable.
- The trend in Italy is that some small companies are making specialised formulations. NPK complex fertilisers import is decreasing while simple straight fertilisers are increasing (general crisis due to drought). Farmers prefer to buy straight fertilisers that are cheaper.
- P is losing share and P deficiency might appear. No change expected in this critical situation in 2013.
- Pier Luigi Graziano is involved in the working group 4 in Brussels. In his opinion, the quality system of Holland is hard to apply to large countries with many manufacturer and retailers.
- → Heinrich JANINHOFF and Jan BRÖRING : BVDM and the German market (ref PowerPoint overview of blending market and research program)

Comments :

- ↓ 2008-2009 was a catastrophic year and the situation is improving since.
- P205 has the lowest level ever.
- ♣ NPK reduced a lot.
- Long winter last year, strong frost damage
- Today, 90-95% is spread while there is still snow in Germany. Although expect some damage on the crops should be ok, adds Jan Broering.
- The consumption of fertilisers has decreased of 8%. Encourage P and K for nutrification.
- Another issue is the alternative energy. The government guarantees the price for the next 20 years. Increase to 3200 mw for 2012 (compared to 1608 mw in 1996).
- BVDM represents 65% of the market; 200 blending stations mainly concentrated in North west in Bavaria.

Nb : KAS = CAN ; Harnstoff = urea, AHL = liquid nitrogen ; andere = others

Fertiliser prices :

- 4 CAN/KAS 285€/T
- 🔸 Urea : 398€/T
- Liquid nitrogen : 245€/T
- 4 CAN even cheaper today : 270€/T
- Prospect : increases of prices and low uses of P, K and Pg.
- 90% is delivered directly to the farmers (no storage), the mixture is done on demand.

## → Jo GILBERTSON – A.I.C. and the British market

(ref. AIC fertiliser statistics 2013 report )

#### <u>Comments :</u>

- ▲ AIC represents 91% of fertiliser market in the UK. The ammonium nitrate is the main fertiliser. The producers are in the north and Northwest of England.
- The cost is becoming a major problem (have to import gas and thus become vulnerable especially towards Russia). UK is also experiencing an interesting time with a consolidation of blenders. Used to have Yara with strong base
- ↓ 66% of total ha were allocated to cereal crop ; 50% to grass
- Overall decrease of nutrient application.
- ↓ There is a real need to educate the farmers, ignorance of what they buy.
- AIC is waiting to see what will be the European legislation. High heavy metal content affects phosphate.
- Jo Gilbertson will go to Brussels at the place of Eileen Pullinger by the end of April while Eileen will step back and remain consultant of AIC.
- At the moment the UK government is concerned of the official definition of the blending. Need to collect what we know from all European countries.

# → Pierre-François DUMAS and Christophe VILLAIN- AFCOME and the French market (ref figures of global market)

#### **Christophe Villain**

Afcome presentation: 21 members all over France who represent 71% of the market. Member size is increasing too.

<u>Comments :</u>

- 4 9 MT of product in France
- 4 Afcome : 5 MT distributed
- 2011/2012 : 700 MT blended in France
  240 blending facilities

Global market :

- AN is the main product.
- **4** UAN mainly in the North of France.
- ↓ Urea is increasing this year : 700T (2010/2011: 855T 2011/2012 : 565T).
- Blend is maintaining its volume.
- **4** The Afcome global market is expanding owing to 2 new big members.
- **4** Big increase of sulphur product (ammonium nitrate and urea).

Pier Luigi Graziano adds that the availability of sulphur is an issue.

Pierre-François Dumas indicates that it comes from Roullier, Fertinagro, Ebré (new plant in Spain), and OCI.

Farmers though buy at the very last time.

Jo Gilbertson adds that the farmers are powerful groups that ask for fixed prices.

An answer, according to Pierre-François Dumas, is to settle a common contract.

Germany agrees on that. Need to discuss that subject at the European level and need EFBA help.

Pierre-François Dumas sends to Jon Broering and to all the members the English version of the contract. Can this way use the example of AIC. Yet need the arbitration of the Chamber of Paris.

Jo Gilbertson mentions that do not know the conditions in which this contract is used, will provide the information shortly. Usually, contracts are confidential in the UK. Need to know if it is used or not.Need a more equilibrate contract for fertiliser in the interest of the suppliers too.

This project is one of the main targets for EFBA. At European level, France and Germany are the leaders of this project supported by UK with the influence of Italy and Holland.

## → Situation of SPAIN and PORTUGAL <u>SPAIN</u>

Pierre-François Dumas says that Spain will not come back in EFBA till the moment they find more benefits in joining. This is the official reaction. It is actually a problem of money since Acefer lost 3 members that went bankrupt. According to Pierre-François Dumas if informs about the new projects of EFBA that will encourage their come back. Some members are ready to join again.

<u>3 possibilities for EFBA</u>:

1/ Contact directly Acefer

2/ Contact suppliers of blenders units : the President of EFBA has liste of 40-50 contacts.

3/ Wait for Acefer's own initiative

Pierre-François is expecting that Acefer will take the initiative in near(?) future. EFBA must keep on working. Acefer will follow the benefits of EFBA. We will wait; no special action for the moment. EFBA needs Spain.

#### **PORTUGAL**

An email with the figures was sent to Maarten Brand. Portugal was very positive after the last meeting. On February 19, Maarten sent an email referring to the 2013 general assembly.

On March 14, he got a phone call from Fernando FRANCO informing him of the uncertain situation of INTERADUBO, we shall wait and see till the end of April. Problem paying the fees as the amount was based on a single company membership. Interadubo will continue its activity but on a smaller scheme. Marteen will keep the contacts with Portugal.

# 5<sup>th</sup> **POINT : Heinrich JANINHOFF - advancement of the research** program

(ref Power Point : comparison of different fertiliser systems with regard to plant nutritional, ecological and economical efficiency)

The research program is a scientific work mainly sponsored by the German blender association. It consists of a comparison of different systems. Prof BRÖRING (marketing aspect), Prof Hans-Werner (research) and Katrin BÖHLENDORF (Master of science in agriculture) are involved.

Total budget : 83.700€

The general framework of the research program is presented to the members. Heinrich Janinhoff, after the agreement of professor BÖHLENDORF (must check in April if ok to send the figures before their publication) will send it to each members who, once having had a look at it, will be able to send back all the questions to be asked.

# Should communicate on the average costs notified in the research program though need to have more details on how they were calculated.

Pierre-François Dumas asks if he could attend the presentation of the research program to the German and Dutch members and also if Professor BÖHLENDORF could come to the international meeting of Afcome in Beaune in October 2013. A presentation to the Dutch blenders is planned for January 2014.

Maarten Brand suggests to put it in the IFS agenda for Cambridge 2014 and adds that EFBA must be convinced about quality as the public might be critical. Pier Luigi adds that it would be more efficient to present this project in an event that is not organised by members of EFBA. The delay is negligible.

Can see photos on the IFS website; this is an opportunity to promote EFBA to the 120 attendees

The decision is taken to give an award in Cambridge in December too.

## **7<sup>th</sup> POINT :** *Christophe VILLAIN – granulometry survey and handbook revue* (*ref PowerPoint*)

### Granulometry survey

French project to develop a system to record the characteristics of products. The actual table on excel is not reliable. Software of analysis and a data base is proposed that will be ready end of April. The suggestion is that all the members use this same system.

This is a good tool to discuss with the supplier especially in case of claims and to increase the quality of material.

Maarten Brand asks : "will members be enthusiastic?"

The first step would be to implement the quality system on the Dutch model.

The data base is operational for 1 member at the moment as a try then will be developed with 3-4 other members. The concrete result will be presented during the next general assembly. The members wait and see.

Pierre-François Dumas adds that the granulometry standard is meant to check and keep things under control. The idea is to create a **shared** data base since the data already exist and allow to see which products reach the standard. This could end up with an official certification too.

Christophe Villain asks if could have the details of the Dutch certification. Maarten Brand will send it.

#### Handbook : code of good practice

The chapter of compatibility needs to be updated. Different in the French and the English versions. A global update is necessary. C,hapter 6, could add documents related to rules of marketing, transport and storage.

In 2014, could update the handbook but have to assess if it is useful and what would it cost. Will have to find sponsors too. Who does it?

Everybody think about it since there is not enough competencies to achieve that before the end of the year. A decision is to be taken before the next meeting.

After the international meeting of Afcome, Christophe Villain will have time to send a proposal to start the work, France takes the initiative.

Maarten Brands says that the research program, the blending award and the update of the handbook are good opportunities for EFBA. Will have to evaluate if a printed version is actually compulsory.

# Pierre-François Dumas – European Commission DG enterprise and the Fertiliser WG

Pier Luigi Graziano says that the commission first did not understand the technical problem only focused on the political aspect. There is a problem of insufficient technical preparation of the commission. Will need professionals and that could be a good opportunity.

Pierre-François Dumas will check the cost. The question remains of who is going to attend. Have to be there to counteract the decisions that are wrongly taken.
